



## Release And Waiver

THIS RELEASE AND WAIVER ("Waiver") for activities provided by the Santa Clarita Warriors Football & Cheer aka Santa Clarita Valley Athletic Association (collectively "Activity Provider").

IN CONSIDERATION of being allowed to participate in the Activity and other good and valuable consideration, the receipt of which is hereby acknowledged, I **(print parent name)** \_\_\_\_\_ (the "Legal Guardian"), agree on behalf of **(print participant name)** \_\_\_\_\_ **DOB** \_\_\_\_\_ (the "Participant") with the Activity Provider to the following:

### DETAILS OF ACTIVITY

1. The participant will be participating in one or more of the following activities including but not limited to: football, cheer, calisthenics, skills and drills, conditioning, speed & agility training (individually and collectively the "Activity") as related to the football and/or cheer.

### CONSIDERATION

2. Being the lawful guardian of the Participant, and in consideration of the Participant being permitted to participate in the Activity, on behalf of the Participant the Legal Guardian releases and forever discharges the Activity Provider, its owners, directors, officers, agents, coaches, legal representatives, successors, and all other program volunteers from all manner of actions, causes of action, debts, accounts, contracts, claims and demands for or by reason of any injury to person or property, including injury resulting in death, and notwithstanding that such damage, loss, or injury may have been caused solely or partly by the negligence of the Activity Provider.
3. The Legal Guardian understands that the Participant would not be permitted to participate in the Activity unless the Legal Guardian signed the Waiver.

### CONCURRENT

4. The Legal Guardian acknowledges that this Waiver is given with the express intention to affecting the extinguishment of certain obligations owed to the Participant by the Activity Provider, and with the intention of binding the Participant's heirs, executors, administrators, legal representatives, and assigns.

### FITNESS TO PARTICIPATE

5. The Legal Guardian acknowledges to the Activity Provider that the Participant does not have any physical limitations, medical ailments, or physical or mental disabilities that would limit or prevent the Participant from participating in the Activity. If required, the Participant will obtain a medical examination and clearance.

### FULL AND FINAL SETTLEMENT

6. The Legal Guardian acknowledges and agrees with the Activity Provider that: (1) the Activity Provider has given the Legal Guardian sufficient time to read this Waiver, (2) the Legal Guardian fully understands the risks and claims that the Participant is waiving to participate in this Activity, (3) the Legal Guardian is freely and voluntarily executing this Waiver, and (4) the Participant is forever prevented from suing or otherwise claiming against the Activity Provider for and property loss or personal injury that the participant may sustain while participating in or preparing the Activity.

### RELEASE & GOVERNING LAW

7. By participating in the Activity, I hereby release the use of: (1) photos that include my Participant and (2) agree to receive communications regarding information from Activity Provider about future events. This Release And Waiver shall inure to the benefit of Activity Provider and its respective successors, licensees and assigns and shall be construed and enforced in accordance with the laws of the State of California.
